

Official Rules 2021 Element Federal Credit Union SpreeWV Superlative Giveaway

No purchase necessary. All entries have an equal chance of winning. Void where prohibited by law.

1. How to Enter: The 2021 Element Federal Credit Union SpreeWV Superlative Giveaway begins at 12:00:01 am (ET) on February 22, 2021 and ends at 12:00:00 pm, midnight on March 31, 2021 (“Promotional Period”). This Giveaway consists of one (1) winner from each SpreeWV Superlative Category; winner(s) will be determined by the one (1) person receiving the most votes for each SpreeWV Superlative Category submitted on www.cwvmainstreets.org/spreewvpeeps.

A SpreeWV + PEEPs Business Employee must submit their own name, employer name, in addition to their SpreeWV Superlative nominee’s name, employer name, and contact information on www.cwvmainstreets.org/spreewvpeeps within the contest period.

One (1) Winner with the most votes from each SpreeWV Superlative Category will receive a \$50.00 cash prize from Element FCU. Maximum one (1) nomination entry per SpreeWV + PEEPs employee per category.

2. Eligibility: Giveaway is open to any person who is employed by a SpreeWV + PEEPs business and who is over 18 or older at time of entry. Element Federal Credit Union employees and volunteers, their immediate families and persons living in their households, whether related or not, are not eligible.
